# **VOLUNTEER AGREEMENT**

#### As a prison and jail volunteer for Prisoners for Christ I agree to:

- 1. Abide by the rules and guidelines as set forth by the administration of Prisoners for Christ in any jail or prison institution.
- 2. Report violations of any volunteer of any rules and guidelines to the administration of Prisoners for Christ.
- 3. Attend the Basic Training Program.
- 4. Be submissive to correctional officers and chaplains of any institution regardless of the situation.
- 5. Do not ask for special privileges of the correctional officers and chaplains of any institution.
- 6. Introduce any sessions as Prisoners for Christ.
- 7. Be able to give an overview of what Prisoners for Christ stands for.
- 8. Be in constant prayer for the volunteers of this ministry, for the ministry needs, and for wisdom and discernment for the leadership of Prisoners for Christ.
- 9. To hold this administration or any person associated with this ministry harmless for any physical or emotional harm due to the carrying out of the duties or responsibilities of this ministry.
- 10. Understand that the purpose of Prisoners for Christ is basically evangelism. Therefore such terms as "baptized in the spirit, faith healing, speaking in tongues" and practices related to these terms, will not be used during PFC sponsored programs. We all agree on the way to salvation, but we don't all agree on some of the "post graduate" areas. Areas of disagreement can cause confusion and disillusionment, thereby harming the cause of Christ. It may even cause some prison officials to cancel programs and volunteers to be asked not to come back. We have seen this happen. We as an organization therefore leave the "post graduate" areas to the new believer, and the Holy Spirit, without our assistance. Many of our volunteers are of this persuasion and would normally use these terms, however while in prison have agreed to this philosophy.
- 11. To be photographed or video taped and to release ownership.
- 12. I understand that membership at a local church is required of me to qualify for acceptance as a Prisoners for Christ volunteer. If I am not a member of a church I agree to become one within six months of today's date.

- 1. Training volunteers in **all aspects** of prison and jail ministry.
- 2. Providing leadership, continuity and camaraderie for volunteers.
- 3. Being the actual authority figure to the inmates in any prison setting. A balance between mercy and strength needs to be exercised.
- 4. Applying discipline to an inmate or a volunteer when necessary.
- 5. Completing required paperwork at any institution.
- 6. Completing Prisoners For Christ Monthly Service Reports by the 5<sup>th</sup> of the following month.
- 7. Understanding the full scope of the Code of Conduct and to be able to teach and train volunteers.
- 8. Understanding the full scope of services and programs provided by Prisoners For Christ.
- 9. Having their family and business life in order.

# CODE OF CONDUCT (I PETER 2: 13-17 NIV)

# **Clearance Procedures**

- 1. For entry into the Correctional Facility, have your <u>driver's license</u> for I.D. If you forget your license you will not be allowed entry. If you are late and your group enters without you, you will not be allowed to enter. Do not be irresponsible and ask for special privileges from jail and prison staff.
- 2. All volunteers will be subject to background investigations 7-10 days prior to admittance. No last minute *substitution* will be allowed.

### **Contraband**

- 3. <u>No items</u>, whatsoever, are to be given to inmates or taken from inmates unless approved by the Chaplain prior to admittance. Everything is considered contraband. You are normally allowed a Bible, pen, and scratch pad. This Is One Rule That Is Punishable By Fine And/Or Imprisonment!!!
- 4. Do not send money, stamps, or any other gift to any inmate. Sometimes inmates see the volunteer program as a means to obtain gifts. This is unacceptable and should always be communicated in a loving fashion.

# Your Relationship with the Prison Staff

- 5. Wait patiently for an officer to assist you. Realize that Officers are frequently <u>very busy</u> and their priorities must come first. If they are too busy to assist you at a particular time, wait patiently.
- 6. When passing through gates or doors, always allow inmates or correction officers to go first.
- 7. Correctional Staff are in control of the security and safety of all volunteers and prisoners. Cooperate with their duties and directions. Practice courtesy with corrections officers and inmates.
- 8. Bring special problems or difficulties to your group leader, Chaplain, or correctional officer. Experiencing problems does not reflect on your ability to render an effective service in any facility. Report any security violations you may become aware of to the Shift Commander on duty and the Chaplain.

# Your Relationship with the Inmate

- 9. Do not loiter in hallways, doorways, etc., (see #5) or hold conversations with inmates in walkways.
- 10. You are here to provide a specific service. Do not become involved in the personal affairs of any prisoners. Do not attempt to accomplish tasks for inmates which fall outside the service. Do not make contact with a prisoner's family, friends, attorneys, or parole officer. Again, if there is a need, share that need with the Chaplain. The Chaplain is our God ordained authority figure.
- 11. Remember your mission is to share Jesus Christ. Many inmates are lonely people, and it is easy for them to respond to Christian kindness in the wrong way. If your intentions are made clear from the start, you will be able to avoid misunderstanding.
- 12. Do not let yourself be drawn into the negative aspects of a person's life. Encourage them to let their "jail time" be used by God to help them grow spiritually.

- 13. Do not let an inmate play on your sympathy, good intentions, or sense of guilt. You are the one directing the content of the correspondence.
- 14. **Do not ask** about the reason for the person's incarceration. Let him volunteer that information.
- 15. Meeting with inmates after they're released is beyond the scope of this ministry and is not allowed for beginning volunteers. Inmates are often released in the late hour of the evening. Do not volunteer to pick him up or take him to your home. Instruct him on available missions. Pray for him.

#### Your Role & Expectation as a PFC Volunteer

- 16. Avoid denominational doctrine unless it is to answer specific questions.
- 17. As a volunteer, periodically review your call to this ministry with an open mind. There is a maturity process that entails **"mountain top and valley experience"** that can result in a workable reality of obedient service.
- 18. Be <u>punctual</u> and regular in attendance as the success of your future endeavor rests greatly on your **credibility**, **consistency**, **and integrity**.
- 19. Dress should be very modest. Gals should wear slacks or skirts at the knee or below. No low cut blouses or sweaters. Jewelry should be at a bare minimum, if any. Men, stylish clothes in our society is appropriate; however, in prison society it may be construed as feminine or homosexual in nature. Your are not here to impress people.
- 20. Keep your word, know the rules and regulations as it relates to the limitations of your ministry. <u>Do not promise things that you may not be able to follow through on</u> (for example, if an inmate makes a request, and you are unsure of the rules and regulations bearing on the nature of that request, do not make any commitment before first finding out what you are allowed, or not allowed to do in such a situation).

# **Miscellaneous**

- 21. Do not take wallets, purses, keys, or money into the institution. Either leave that material in your locked car, or rent a locker that is provided at many institutions. Remember you will need your driver's license always.
- 22. If you desire to write an inmate, check with the prison ministry for guidelines to our Pen Pal Program.
- 23. Become acquainted with the Prisoners For Christ Ministries, a non-denominational ministry designed for support of prisoners and volunteers regarding follow-up programs, Bible studies, Pen Pal Program, etc.
- 24. Stick with it, constantly pray for the discernment of the Holy Spirit, and above all--BE A FRIEND! *Remember you are Ambassadors of Christ.*

# STATEMENT OF VOLUNTEER POLICIES

# **Sexual Purity Statement**

- In an age where secular society is increasingly confused about sexual identity and sexual purity, the leadership of Prisoners for Christ Outreach Ministries believes that it is important that it be clear with its staff /missionaries /employees/ volunteers about its expectation that they uphold the highest standards of Biblical purity in their interpersonal relationships. Without a clear understanding of sexual identity and consistent practice of sexual purity by our staff/missionaries/employees/ volunteers, the leadership of Prisoners for Christ Outreach Ministries cannot be an effective agent of the healing power of Jesus Christ to the victims of sexual confusion in our world.
- We believe that God's design for sexual activities is that it is to be exercised and enjoyed only within the covenant relationship of marriage between one man and one woman. It is God's intention that those who enter marriage shall seek, in mutual love and respect, to live, one man and one woman, in Christian fidelity as long as both shall live.
- We believe that God has expressly condemned sexual intercourse outside of the marriage covenant. This prohibition applies to married persons committing adultery, to sexual relationships between unmarried men and women, and, because God's order intends the sexual relationship to be between male and female, to homosexual practice. It is God's expectation that the unmarried shall live pure and celibate lives, refraining from sexual intimacy.
- Because of the serious consequences, confused sexuality, and unrepentant sexual sin can have on the ministry of this organization, missionaries employees and volunteers who disagree with this policy, or who do not conform their conduct to it, are expected to resign, or they will be terminated. Individuals applying for positions with this organization must acknowledge their agreement with this policy and commitment to abide by it.

# **Alcohol and Drug Policy**

- It is the policy of Prisoners for Christ that any volunteer or Prisoners For Christ support staff will refrain from alcohol consumption prior to a Prisoners For Christ sponsored event. Any Prisoners For Christ individual smelling of alcohol while ministering in the jails will be immediately asked to leave the premises. A meeting will be scheduled to discuss the situation at which time the individual will be given a verbal warning. A second occurrence will result in the dismissal of the individual from Prisoners For Christ for six months.
- Prisoners For Christ has the expectation that all volunteers are committed to a drug free life-style.

Keep your word, know the rules and regulations as it relates to the limitations of your ministry. **Do not** promise things that you may not be able to follow through on (for example, if an inmate makes a request, and you are unsure of the rules and regulations bearing on the nature of that request, do not make any commitment before first finding out what you are allowed, or not allowed to do in such a situation).

# **VOLUNTEER AGREEMENT**

#### As a prison and jail volunteer for Prisoners for Christ I agree to:

- 1. Abide by the rules and guidelines as set forth by the administration of Prisoners for Christ in any jail or prison institution.
- 2. Report violations of any volunteer of any rules and guidelines to the administration of Prisoners for Christ.
- 3. Attend the Basic Training Program.
- 4. Be submissive to correctional officers and chaplains of any institution regardless of the situation.
- 5. Do not ask for special privileges of the correctional officers and chaplains of any institution.
- 6. Introduce any sessions as Prisoners for Christ.
- 7. Be able to give an overview of what Prisoners for Christ stands for.
- 8. Be in constant prayer for the volunteers of this ministry, for the ministry needs, and for wisdom and discernment for the leadership of Prisoners for Christ.
- 9. To hold this administration or any person associated with this ministry harmless for any physical or emotional harm due to the carrying out of the duties or responsibilities of this ministry.
- 10. Understand that the purpose of Prisoners for Christ is basically evangelism. Therefore such terms as "baptized in the spirit, faith healing, speaking in tongues" and practices related to these terms, will not be used during PFC sponsored programs. We all agree on the way to salvation, but we don't all agree on some of the "post graduate" areas. Areas of disagreement can cause confusion and disillusionment, thereby harming the cause of Christ. It may even cause some prison officials to cancel programs and volunteers to be asked not to come back. We have seen this happen. We as an organization therefore leave the "post graduate" areas to the new believer, and the Holy Spirit, without our assistance. Many of our volunteers are of this persuasion and would normally use these terms, however while in prison have agreed to this philosophy.
- 11. To be photographed or video taped and to release ownership.
- 12. I understand that membership at a local church is required of me to qualify for acceptance as a Prisoners for Christ volunteer. If I am not a member of a church I agree to become one within six months of today's date.
